Step 1

Initial Contact

Step 2

Visa Eligibility

We check visa eligibility of each person using the **Visa Entitlement Verification Online (VEVO)**.

We use this to check type of visa and if the person holds study and work rights.

1. Identify the person's hopes, goals and interests
2. Discuss their previous work and study history
3. Check what courses they have in mind and if these
lead to employment outcomes
