If you need of legal assistance and/or representation and can't afford to pay for a lawyer, you can call the following telephone advice lines:

Refugee Legal (formerly RILC)

Refugee Legal specialises in free legal advice and representation in relation to refugee and general immigration matters. Refugee Legal provides assistance to applicants who arrived by plane and boat, and also has funding to assist plane arrivals under IAAAS (see below).

Victoria Legal Aid (VLA)

VLA has a range of services to help people with their legal problems. A Victoria Legal Aid lawyer may be able to give you general information about applying for a protection visa, and may also be able to help with applications for judicial review (Federal Circuit Court).

Immigration Advice and Assistance Scheme (IAAAS)

If you arrived in Australia by <u>plane with a valid visa</u>, and need assistance at the <u>primary</u> stage of the refugee determination process (ie applying for protection at the Department of Immigration), you can try contacting the following IAAAS providers, who may be able to assist you for free.

The IAAAS scheme is funded by the Australian government to give free migration advice and visa application assistance to people who have arrived lawfully in Australia and who meet specific eligibility criteria with respect to financial or other vulnerability.

Paid Legal Services

The lawyers listed below may help you with your immigration matter. They will charge fees for their assistance, called legal fees or professional fees.

A lawyer must give you a 'costs agreement.' This document is your legal contract with your lawyer and explains how much money you must pay, when you must pay it, and what you can expect from your lawyer.

The ASRC recommends the following lawyers for assistance in relation to:

- Protection visa applications and interviews at the Department of Immigration;
- Administrative Appeals Tribunal review applications;
- Federal Circuit Court, Federal Court and High Court;
- Humanitarian requests to the Minister of Immigration;
- Family visas, skilled visas, work visas and student visas;
- Complex health and character matters.
- Visa cancellations and responses to adverse information.
